- TERMINATION: Either Party may terminate this MOU by giving thirty (30) days written notice to the other Party.
- CONFIDENTIALITY: The Parties agree to keep confidential all information and data provided by each other under this MOU.
- APPLICABLE LAW: This MOU shall be governed by and construed in accordance with the laws of India.
